

# Vacation Credit Terms and Conditions

*Last updated: March 15, 2019*

These Vacation Credit Terms and Conditions (“Terms”) set out the terms and conditions that apply to the Vacation Credit program and your use of a Vacation Credit towards booking a vacation on [www.vacationbonusbucks.com](http://www.vacationbonusbucks.com). Your qualification and use of the Vacation Credit towards an RCI vacation indicates your acceptance of these Terms, as well as the Resort Rental, LLC Website Terms of Use (“RR Terms of Use”), incorporated herein by reference. Please read them carefully. If you don’t agree to these Terms and RR Terms of Use, you may not use the Vacation Credit or vacations offered through this program.

These Terms are in addition to the RR Terms of Use, but only to the extent necessary to govern your use of the Vacation Credit and RCI vacation. Capitalized terms not defined in these Terms will have the same meaning as in the RR Terms of Use. If these Terms expressly conflict with the RR Terms of Use, these Terms will govern and control.

## **1. Earning Vacation Credit**

- a. RCI<sup>®</sup> Elite Rewards<sup>®</sup> Program cardmembers (each a “Cardmember”) who use their RCI<sup>®</sup> Elite Rewards<sup>®</sup> Mastercard<sup>®</sup> Account (“Account”) and spend ten thousand (\$10,000) in Net Purchases (defined below) during a calendar year will receive \$250.00 credit (“Vacation Credit”) that may be used to book a vacation from select RCI vacation rental inventory on [vacationbonusbucks.com](http://vacationbonusbucks.com).
  - i. Net Purchases are purchases less credit, returns and adjustments made by the Cardmember or any authorized user of the Account, as defined in the RCI<sup>®</sup> Elite Rewards<sup>®</sup> Mastercard<sup>®</sup> REWARD RULES (“Reward Rules”). RCI reserves the right to exclude certain purchases from the qualifying Net Purchases at any time, in its sole discretion.
  - ii. Transaction dates on qualifying purchases must occur during the calendar year, from January 1<sup>st</sup> through December 31<sup>st</sup>.
- b. Purchases that are made by authorized users of the primary Cardmember’s Account are eligible and qualify towards the \$10,000 qualifying spend on Net Purchases. However, only the primary Cardmember on the Account is eligible to receive the \$250.00 Vacation Credit. See Section 3. Limitations for further details.

## **2. Redemption**

- a. Cardmembers who qualify for a \$250 Vacation Credit must setup an online account on [vacationbonusbucks.com](http://vacationbonusbucks.com) in order to redeem and use their Vacation Credit.
- b. The primary Cardmember on the Account will receive an activation email from RCI which will include an activation website link that the Cardmember must use in order to activate his or her online account. Cardmembers will have 30 days from receipt of the email to activate their account, which includes acceptance of these Terms, before the activation link expires.

- i. Email with the activation link will be sent within 6-8 weeks from the date the Account has reached the \$10,000 qualifying spend in Net Purchases.
  - ii. RCI will send the activation email to the email address listed in the Account of the primary Cardmember.
- c. Upon activation of the online account, the Cardmember will be able to use the \$250 Vacation Credit towards booking select RCI vacation rental inventory, subject to availability.
  - i. The \$250.00 credit will be automatically applied and deducted from the listed rental price. Cardmembers are responsible for and must pay any remaining balance of the rental price in order to book a reservation.
  - ii. RCI may change the required transaction fees and/or rental rates, in its sole discretion and without prior notice.
- d. Cardmembers will have thirteen (13) months from the date the activation email is sent from RCI to the Cardmember's email address to use their \$250 Vacation Credit.
- e. Reservations can be made up to 365 days in advance of travel, but no less than two (2) days prior to the check-in date. If a reservation has a travel start date beyond the date on which the Vacation Credit online account expires, Cardmembers will still be able to access their account in order to view or cancel a pending reservation.

### **3. Limitations**

- a. Only one (1) \$250 Vacation Credit may be earned per calendar year, regardless of the amount of Net Purchases during the calendar year.
- b. A Vacation Credit is only eligible for use towards a single, one-time reservation transaction, subject to the cancellation policy. A Vacation Credit cannot be combined with any future earned Vacation Credits.
- c. Vacation Credits have no cash value.
- d. Only the primary Cardmember on the Account is eligible to receive the \$250.00 Vacation Credit.
- e. Vacation Credits may only be redeemed on [www.vacationbonusbucks.com](http://www.vacationbonusbucks.com) and are not valid for use on any other RCI websites or RCI-affiliated websites.
- f. Inventory availability may vary, including the length of stays, with a maximum length of stay of seven (7) nights.
- g. Cardmembers must be at least 21 years old, unless otherwise permitted by law, and subject to resort policies which may impose a minimum age greater than 21 year old. Vacation Credits are limited to Cardmembers who are U.S. residents only.
- h. Vacation Credits, including access to select rental reservations through [vacationbonusbucks.com](http://vacationbonusbucks.com), will expire thirteen (13) months from the date the activation email is sent from RCI to the Cardmember, subject to any pending reservations.

- i. Vacation Credits cannot be used for commercial purposes, including, without limitation, auction, barter, rental, raffle or sale.
- j. RCI reserves the right to limit the number of transactions by a Cardmember, in its sole discretion.
- k. In addition to the transaction fees charged to book a reservation, additional fees may be required by resorts or other inventory providers, including, but not limited to, taxes, port charges, gratuities, utilities, security deposits, all-inclusive fees, resort fees and any other fees charged. Cardmembers are responsible for all such fees.

#### **4. Cancellations**

- a. You may cancel a reservation online at [www.vacationbonusbucks.com](http://www.vacationbonusbucks.com). All reservations are subject to the following cancellation policy:
  - i. If the Cardmember cancels a rental reservation within 24 hours of booking a reservation and 31 days or more prior to the check-in date, 100% of the total reservation fee paid and Vacation Credit shall be refunded.
  - ii. If the Cardmember cancels a rental reservation after 24 hours of booking a reservation and greater than 61 days prior to the check-in date, 100% of the total reservation fee paid and Vacation Credit shall be refunded.
  - iii. If the Cardmember cancels a rental reservation after 24 hours of booking a reservation and between 32 days and 60 days prior to the check-in date, 50% of the total reservation fee shall be refunded. In addition, the Vacation Credit shall be refunded.
  - iv. If the Cardmember cancels a rental reservation 31 days or less prior to the check-in date, the total reservation fee is non-refundable, regardless of whether the cancellation occurs within 24 hours of booking. However, the Vacation Credit shall be refunded.
- b. In the event your Vacation Credit is refunded due cancellation, the Vacation Credit will be placed back onto your account for future use through the program; however, the Vacation Credit shall retain its original expiration date.

#### **5. Miscellaneous**

- a. Vacation Credits and this program are managed by RCI, LLC. RCI reserves the right, in its sole direction, to modify, change, or discontinue Vacation Credits, this program and these Terms, at any time and without advance notice.
