Ancillary Travel Products Terms & Conditions

These Ancillary Travel Products Terms & Conditions are intended to supplement and not replace the Terms and Conditions of RCI Points® Subscribing Membership, the Terms and Conditions of RCI Weeks® Subscribing Membership and RCI Platinum® Membership Rules available at rci.com.

1. Your booking and exchange of Points and/or Deposit Trading Power, as applicable, for Ancillary Travel Products are subject to the terms and conditions set forth in the Terms and Conditions of RCI Points Subscribing Membership (if you are an RCI Points Member), RCI Weeks Subscribing Membership (if you are an RCI Weeks Member), and/or the RCI Platinum Membership Rules (if you are an RCI Platinum Member), together with these Ancillary Travel Products Terms & Conditions. In addition, you are also subject to the terms and conditions of the applicable Ancillary Travel Products Provider, including but not limited to restrictions due to black-out dates or unavailability.
2. RCI may at any time, in its sole discretion, add, amend or terminate any product(s) and/ or service(s) which are Ancillary Travel Products.
3. RCI and each Ancillary Travel Product Provider are separate and distinct entities, and RCI may have no control over the operation of certain of the Ancillary Travel Product Providers.
4. Based on their applicable Home Group and certain other characteristics determined by RCI in its discretion, RCI Members who are eligible to use the Ancillary Travel Products may be restricted from using some or all of the total number of Points and/or Deposit Trading Power available to them towards Ancillary Travel Products transactions. For information on your specific eligibility for the Ancillary Travel Products, please contact an RCI Travel Guide (?) at 1-877-968-7476.
5. Renting Points from RCI for the Ancillary Travel Products transactions is not permitted. Using borrowed, saved or extended Points for Ancillary Travel Products transactions may be permitted.
6. Eligible Members may exchange Points and/or Deposit Trading Power for discounts off the value of travel products and services. For each Ancillary Travel Products transaction, there will be a specified maximum number of Points and/or Deposit Trading Power that may be used, as well as a minimum number of Points and/or Deposit Trading Power required. In addition, for each Ancillary Travel Products transaction, there may be a cash component required. The number of Points and/or Deposit Trading Power, as well as the discounts, may change from time to time in RCI's sole discretion, based on factors such as the product type, price and timing of the Ancillary Travel Products opportunities. RCI guides will be available, at 1-877-968-7476 or other numbers published by RCI from time to time to assist Members. In addition, depending on availability, Members may have online access at www.rci.com to the most current Ancillary Travel Products discounts, all discounts, Point and/or Deposit Trading Power amounts and values remain subject to change without notice at the sole discretion of RCI.
7. After the discount has been deducted from the cost of the transaction, any remaining cost must be paid by the member with cash (by debit card) credit card, or any other method of payment accepted by RCI in its discretion at the time of the transaction. For example, if a hotel night has a retail value of \$125 and the member chooses to exchange 2,000 Points for a \$25 discount (please note that actual discounts will vary depending on the details of each transaction), the remaining \$100 may be paid by cash or credit card.
8. Unless otherwise stated, Members will not earn Travel Rewards on Ancillary Travel Products transactions.

9. Additional restrictions and/or terms and conditions may apply for any particular Ancillary Travel Products transaction. See the individual Ancillary Travel Products Provider for such restrictions and/or any other additional terms and conditions.
10. Products and/or services offered by Ancillary Travel Product Providers are subject to availability and certain blackout dates may be imposed by RCI or the Ancillary Travel Products Provider without further notice.
11. RCI transaction fees, as promulgated by RCI from time to time in its discretion, may apply to the usage of Points and/or Deposit Trading Power for Ancillary Travel Products transactions.
12. Unless otherwise stated at the time of booking, all Ancillary Travel Products transactions are completely non-refundable, non-changeable and nontransferable and are subject to the terms and conditions of the carrier/provider in addition to any RCI terms and conditions.
13. Subject to the additional restrictions set forth herein, any Points and/or Deposit Trading Power exchanged for Ancillary Travel Products transactions will be subject to a limited grace period where by any Ancillary Travel Products transaction cancelled by the close of business the following day may be eligible for a full refund of any Points and/or Deposit Trading Power exchanged. After the close of business the following day, all Points and/or Deposit Trading Power exchanged will be forfeited in the event of a change or cancellation. Notwithstanding the foregoing, if an Ancillary Travel Product transaction is made within three days of the date of travel, such transaction is final and no grace period will apply to the exchanged Points and/or Deposit Trading Power. Any other amounts paid, whether by cash (by debit card) or credit, will be subject to the cancellation policy of the Ancillary Travel Products Provider and will not be subject to any grace period.
14. RCI does not warrant the suitability, safety or security of resort activities, guides, vendors or service providers described herein. It is the member's responsibility to investigate the safety and suitability of any activity, and the credentials and fitness of any guide, vendor or service provider, and members participate at their own risk. RCI expressly disclaims any express or implied warranty or any liability in connection with such resort activities, guides, vendors or service providers. Information about Ancillary Travel Products Providers' products and/or services published by RCI is based on information obtained from the relevant Ancillary Travel Products Provider. Therefore RCI cannot accept responsibility for, and shall have no liability for any inaccurate, incomplete or misleading information provided concerning Ancillary Travel Products.

Any applicable vendor, guide, or service provider may, in its sole discretion, impose additional fees, terms, conditions and restrictions to any activity or service, and such additional fees, terms, conditions and restrictions are subject to change at the sole discretion of the service provider, guide or vendor. In addition, rules or regulations may be imposed by government agencies, states, municipalities, or similar bodies related to a member's travel plans. It is the responsibility of the member to determine if any such additional laws, regulations, fees, terms, conditions and restrictions apply to their transaction. RCI does not warrant the availability of third party activities or services.

If RCI or any Ancillary Travel Product Provider should be prevented, hindered or delayed in the performance of any obligation hereunder, including, but not limited to, providing accommodations or other travel services, due to a "Force Majeure" beyond its reasonable control, then such party shall be excused from further performance. The term "Force Majeure", as used herein, shall mean and refer to (i) an act of God or public enemy, fire, explosion, perils of the sea, lightning, earthquake, storm, flood, declared or undeclared war, revolution, insurrection, riot, act of piracy, act of terrorism, sabotage, blockade, embargo, accident, pandemic, epidemic or quarantine; (ii) action by a governmental authority which prevents or delays performance such party's obligations hereunder; or (iii) a strike, lockout or other labor unrest resulting from any cause and whether or not the demands of the employees involved are reasonable or within such party's power to

concede. Notwithstanding RCI or any Ancillary Travel Product Provider's inability to perform any obligation hereunder, the member's obligations hereunder shall continue
